 working days in advance of your account being debited or as otherwise agreed. If you request The Nottingham Park Estate Ltd to
 collect a payment, confirmation of the amount and date will be given to you at the time of request.
- If an error is made in the payment of your Direct Debit, by The Nottingham Park Estate Ltd or your Bank or Building Society, you are entitled to a a full and immediate refund of the amount paid, from your bank or building Society.
 - If you receive a refund you are not entitled to, you must pay it back when The Nottingham Park Estate Ltd asks you to.
- You can cancel a Direct Debit at any time by simply contacting your Bank or Building Society.
 Written confirmation <u>may be</u> required. Please also notify us.

Payment of Perpetual Rentcharge Demands

The 1st half yearly demand becomes due on 1 July

- This if for the period 1 April to 30 September

The 2nd half yearly demand becomes due on 1 January
